The undersigned has read and acknowledges safety rules of the Gun Range. The undersigned acknowledges the printed and posted Range Rules and gun safety video. As additional consideration for the use of the Gun Range, the undersigned, for himself/herself and his/her heirs, executors, administrators, legal representatives, successors, assigns and for anyone claiming by, through or under the undersigned, hereby forever and completely RELEASES, ACQUITS and FOREVER DISCHARGES Lake Fork Firearms, LLC, its officers, members, employees, and instructors affiliated with Lake Fork Firearms, LLC, and each of them and their respective heirs, executors, administrators, legal representatives, successors and assigns and any one claiming by, through or under such persons, individually and in all capacities (Collectively, the “Lake Fork Firearms, LLC Parties”) from and against any and all claims, liabilities, demands, obligations, right, damages, (whether actual, exemplary or punitive, costs, expenses and causes of action of any nature, kind or character) (whether tort, contract, or statutory, known or unknown, suspected or unsuspected, fixed or contingent, in law or in equity, including claims based on strict liability or the sole, concurrent and/or gross negligence of the Lake Fork Firearms, LLC Parties, or any of them) that the undersigned may now have or that may ever accrue in the future to the undersigned that are based on, relate to, arise from, or are in any way connected with any act, omission, communication, representation, warranty, covenant, agreement or course of conduct of or by the Lake Fork Firearms Parties.

The undersigned hereby affirms that he/she has read this Waiver & Release, the Range Rules, and watched the firearm safety video and understands that handling and use of firearms involves a risk of injury or death to myself or third persons and assumes any and all risks of entering and using the Gun Range.
